SECOND AMENDMENT TO 2023-2025 DANE COUNTY ASSIGNMENT SYSTEM

The Honorable Frank D. Remington, Presiding Judge, approved by Chief Judge Julie Genovese, hereby amends the Amendment to the Order of Case Assignments for the Dane County Circuit Court (which are attached) as follows:

- 1. Civil Case Draw. Effective November 1, 2024, Judge Remington will no longer receive a 2% case reduction because he is the presiding judge. Therefore, each civil judge will receive 14.17% of the civil draw.
- 2. Family (FA/PA) Case Draw. Effective November 1, 2024, Judge Remington will no longer receive a 2% case reduction because he is the presiding judge. Therefore, each civil judge will receive 8.33% of the family draw.

Except as provided herein, all other provisions of the original 2023-2025 Dane County Assignment System and the Amendment to the 2023-2025 Dane County Assignment System (which are attached) remain in effect.

AMENDMENT TO 2023-2025 DANE COUNTY ASSIGNMENT SYSTEM

The Honorable Frank D. Remington, Presiding Judge, approved by Chief Judge Julie Genovese, hereby amends and enters the Order of Case Assignments for the Dane County Circuit Court (which is attached) as follows:

- 1. Criminal Division Draw. Effective August 1, 2024, Chief Judge Genovese, in recognition of her administrative responsibilities, will receive an approximate 2.5% case reduction. Therefore, she will receive 10% of the criminal draw, and the remaining seven criminal judges will receive 12.86%.
- 2. Civil Case Draw. Effective August 1, 2024, Judge Remington will receive an approximate 2% case reduction in recognition of his administrative responsibilities. The civil draw therefore will be divided as follows: Judge Remington will receive 12.5%; the remaining five civil judges will draw 14.5 %; and each of the three juvenile judges will draw 5%.
- 3. Family (FA/PA) Case Draw. Effective August 1, 2024, the three juvenile judges will split 50% of the FA/PA cases filed equally (16.7% each). The remaining civil judges will receive 8.7% of the FA/PA cases, except Judge Remington will receive 6.4%.
- 4. Guardianship (GN) Case Draw. Effective August 1, 2024, the three juvenile judges will split 100% of the GN cases filed equally (33.3% each).
- 5. OWI Treatment Court. Effective January 1, 2025, Judge Nilsestuen will assume responsibilities for this court.

Except as provided herein, all other provisions of the 2023-2025 Dane County Assignment System (which is attached) remain in effect.

Dane County Case Assignment System Pursuant to Rotation Plan August 1, 2023 through July 31, 2025

The Honorable Frank D. Remington, Presiding Judge of Dane County, hereby enters this Order of Case Assignments for the Dane County Circuit Court, approved by Chief Judge Thomas J. Vale.

Criminal Division

Effective August 1, 2023, the following judges will be in the criminal division:

Josann Reynolds (Br. 2) Ellen Berz (Br. 11) (Veterans Court)
Diane Schlipper (Br. 3) Julie Genovese (Br. 13)
Nicholas McNamara (Br. 5) John Hyland (Br. 14)
Mario White (Br. 7) David Conway (Br. 17)

Effective April 1, 2023, the random draw for criminal cases assigned to these judges will begin.

Each judge will receive an equal number of cases, 12.5% of the draw, except the judge with Veterans Court responsibility will not be assigned Small Claims dates. Criminal division judges will not be assigned any new civil/family/probate filings but will retain pending and past cases.

Pursuant to Circuit Court Rule 205, if any new case filed after April 1, 2023 has a defendant with a legal status from a prior case that may cause an appearance before a judge, and the judge who would normally be assigned is leaving the criminal division, the case will be assigned to the judge entering the division who is teamed with the outgoing judge for the purpose of calendar and schedule coordination instead of a random draw. Further, open criminal cases (CF/CM/CT case types) pending with the outgoing judge that involve a defendant in a newly filed criminal case will be administratively transferred to the incoming judge unless the cases are already scheduled with the outgoing judge for trial or plea/sentencing, or the affected judges determine the posture of the cases warrants them remaining with the outgoing judge.

Hearings on cases assigned to judges entering the criminal division should only be scheduled prior to August 1, 2023 when absolutely necessary, such as pleas for "time-served" and bail hearings or when prearranged with your 'team' member. To the extent possible, judges leaving the division will complete cases prior to August 1, 2023. Overlap should be minimized.

To minimize attorney conflicts, scheduling of cases remaining with the judge leaving the division (Judge Taylor) shall be coordinated with the scheduling of cases assigned to the judge remaining in or entering the division. The judges in each 'team' should not both schedule criminal matters on the same days for the period between April 1, 2023 and August 1, 2023.

Judge Taylor (Br. 12) will be paired with Judge Schlipper (Br. 3).

Civil Division

Effective August 1, 2023, the following judges will be in the civil division:

Susan Crawford (Br. 1) (OWI Court)

Frank Remington (Br. 8)

Jacob Frost (Br. 9)

Stephen Ehlke (Br. 15)

Chris Taylor (Br. 12)

Rhonda Lanford (Br. 16)

Effective Monday, February 1, 2023, the draw for civil/family/probate cases assigned to these judges and the judges in the juvenile division will begin. Each civil division judge will be assigned 14.5% of new filings, with the following exception. The judge with presiding judge responsibilities will receive a caseload reduction. The judge with OWI Court responsibilities will not be assigned Small Claims dates. Each juvenile division judge will be assigned approximately 5.8% of new civil/family/probate filings.

Juvenile Division

Effective August 1, 2023, the following judges will be in the juvenile division:

Everett Mitchell (Drug Court) (Br. 4) Nia Trammell (Br. 6) Juan Colás (Br. 10)

Effective June 1, 2023, the draw for juvenile cases assigned to these judges will begin.

Each judge assigned to the juvenile court division shall be assigned one-third of the juvenile cases. Each judge assigned to the juvenile court division is assigned approximately 5.8% of the civil/family/probate cases, with the following exception. The judge with Drug Court responsibilities will be not be assigned Small Claims dates.

A judge leaving the juvenile division (Judge Crawford) shall be assigned new cases through May 31, 2023 and shall make every attempt to complete all pending motions and petitions prior to August 1. Beginning June 1, 2023, any judge (Judge Trammell) entering the division shall be assigned new juvenile cases of any type.

During June and July 2023, a judge leaving the division will be assigned all petitions and motions involving a child already assigned to that judge if that judge has an active petition or motion that is not resolved. The judge will retain jurisdiction until that motion or petition is resolved. All petitions and motions filed in June and July 2023 involving a child not already assigned to a judge will be assigned through the normal, random juvenile draw. Any petitions filed on or after August 1, 2023 will be assigned through the normal, random juvenile draw pursuant to policies previously adopted.

In June 2023 Judge Trammell shall assume cases with juveniles previously assigned to Judge Crawford. Judges leaving the division will not retain jurisdiction in cases beyond disposition of a pending matter unless specifically approved by the Chief Judge.

To minimize attorney conflicts, scheduling of cases remaining with the judge leaving the division shall be coordinated with the scheduling of cases assigned to the judges entering the division. Judge Crawford and Judge Trammell shall coordinate schedules. The judges in this 'team' should not both schedule juvenile matters on the same days for the period between June 1, 2023 and August 1, 2023 and should only schedule the type of juvenile cases permitted by the Master Calendar of the outgoing judge.
